SPEAKER (from page 1): Our April meeting speaker is Libby Harper, who is the Community Outreach Assistant for Dr. Kenneth Todd with the Center for Vein Restoration in Dothan. Dr. Todd is a Phlebologist who has been working in this field for almost 20 years.

Center for Vein Restoration's Community Outreach program hosts and attends health and wellness events in conjunction with community centers, corporations, I school systems, union groups, women's organizations, churches, and senior centers.

The program's mission is to promote vein health I education by providing seminars that educate people about leg vein health and the dangers of vein disease, as well as, providing lower leg vein ultrasound demonstrations. Since I the program's inception in 2014, they have held more than 1,200 events across the country and helped more than 1,500 community members address their vein issues.

Ms. Harper will be talking about how veins work and some of the things people can do to help their veins move the blood through them. She will also talk about symptoms occurring when the veins do not work correctly, MENT—"Work and what can be done to help treat them. At the end of the talk, she will be offering to provide an ultrasound scan from the knees down only. If you are interested in this no cost option, please wear loose fitting pants or clothing. 



Chaplain's Corner by Ben McKee

As we begin this season of Lent 2018, I am reminded of the song, "When He was on the Cross we were on His mind." Often times

when we are going through particularly difficult circumstances, it is hard to see anything else. It is very easy to become self-absorbed in our own problem and lose sight of the fact that others around us are going through their own problems. But as the song says, Jesus wasn't like that.

I find it interesting that Jesus, when facing the agony of the Cross, still had the welfare of His disciples on His mind. At the end of John 16 we find that He had just told them that the hour was coming when they would all scatter and abandon Him, but he assures them that when that time would come He would not truly be alone because the Father would be with Him.
