Currently there are several bills in Congress. You should look these over and send an email to show your support for providing better benefits for medical retirees and survivor benefits. The link is below. The MOAA website begins the discussion on the upcoming Ouadrennial Review:

Compensation is Crucial to Recruitment and Retention

Don't keep chipping away at military compensation

The president has requested DoD commence with the 13th Quadrennial Review of Military Compensation (QRMC) to assess the adequacy of military compensation and, essentially, decide if a salary system would be more effective for recruiting and retention.

This study will result in a report to Congress focusing on the potential for a salary system. The concern is whither or not it will be used to reduce military compensation in any way.

SBP Premiums & CRSC

If you receive Combat-Related Special Compensation (CRSC) and have the Survivor Benefit Plan (SBP), you may see a change in your net pay and statements starting in April. Beginning with the SBP premiums in April, DFAS will start deducting SBP premiums from CRSC when retired pay is not sufficient to cover the full amount of premiums. This new deduction is due to a change in the law which requires DFAS to deduct SBP premiums from CRSC. See https://www.dfas.mil for more information. [Extracted from Army Echos, Feb.-May, 2018.]



Some years ago I preached a sermon, "He speaks from the Grave" for a Memorial Day service at the Church I served at the time. The text for the

sermon was Hebrews 11: 4, where the writer says of Abel, "<u>He being dead yet speaketh</u>." I cannot remember all the points and will not attempt to repreach the sermon in this short devotion; however, with Memorial Day coming or just having passed when you read this, I do want to dwell on that subject for a few lines.

At home in Oklahoma this special day is called "Decoration Day" for that is the day when the families of the deceased come to the cemetery, decorate the graves, and have dinner on the grounds reminiscing about their loved ones who have gone on before. Many a time as a young boy I can remember those old saints saying, "I can just hear old Ed" (or Jim, or Louise, or whomever) saying......" or "Can't you just hear Mae speaking to us about".

Yes, it does seem that those who have preceded us in death still speak to us today. Every day that we live, we live out the things we were taught by our parents. My Christian Mother taught me the precepts and principles of God from the Bible, else I would have never been called to preach the Word, and attend seminary where professors could instruct me in church administration and operation. Many times that still small voice of my Mom has softly spoken within my brain to allow me to defuse some controversy between others--and a thousand times over in making the right decision in spiritual matters. She still speaks from the grave. My Dad was a tough farmer—an astute business man. He had no patience with anyone who disobeyed the law. He was firm in his business relations and taught me well. I have not always been as strict in my business dealings with others as he, but you can bet I could hear his voice over my shoulder warning me when I was about to give in to something that was wrong for me or my family. He sill speaks from the grave. For many of us it is true that though our parents are dead, they still speak. They influence our lives every day. Unconsciously it may be, that we still seek their approval in the things we do. May God grant unto us to pass on to our



children the heritage our parents passed on to us.

It is profoundly true that many a teacher being dead, yet still speaks through his former pupils. A good teacher is always immortal in someone's life. Having taught for 28 years at the Warrant Officer Career College—11 years a military instructor and another 17 as a civilian instructor—I beam with joy when a former student mentions something I taught him or her. To have influenced someone's life in a positive way cannot help but make one's life seem worthwhile. I loved to see the light come on in a student's eyes when I realized he or she had grasp a tenet I was teaching. I pray that some will remember and utilize the things I taught in Leadership, Management, Writing, Speaking, and Critical Thinking/Problem Solving Skills. I, like others, hope that I will speak to some beyond my years on earth.

I could not help but wonder as I prepared for this topic what our veterans who have sacrificed their lives for this country would say if they could speak from their graves today. What advice would they give us in handling the problems in our society, our military, and our government. Have they spoken to you? And if so, what was their advice or what actions do you think they would take if they were in our shoes—Just a thought.

And what will you say from the grave? What will you leave for others to use to help them cope with life as they face it long after you are gone? Every person leaves something of him or herself in the world. Being dead, you will speak. May what we leave in this world be something positive that will continue to speak to others. Have a blessed Memorial (Decoration) Day!

INCREASE TO TRICARE PHARMACY COPAYMENTS ARE HERE!

Washington—On February 1, 2018, copayments for prescription drugs at TRICARE Pharmacy Home Delivery and retail pharmacies increased. These changes are required by law and affect TRICARE beneficiaries who are not active duty service members. While retail pharmacy and home delivery copayments will increase, prescriptions filled at military pharmacies remain available at no cost. You can save the most money by filling your prescriptions at military pharmacies. Using home delivery, the copayments for a 90-day supply of generic formulary drugs will increase from \$0



to \$7. For brand-name formulary drugs, copayments will increase from \$20 to \$24, and copayments for non-formulary drugs without a medical necessity will increase from \$49 to \$53.

At retail network pharmacy, copayments for a 30-day supply of generic formulary drugs will increase from \$10 to \$11 and from \$24 to \$28 for brand-name formulary drugs. If you want a 90-day supply from your network pharmacy, you'll pay the cost for each 30-day supply. Copayments remain the same as 2017 rates for dependent survivors of Active Duty Service Members and medically retired service members and their dependents.
