

#### The PACT Act and Your VA Benefits

The PACT Act is a law that expands VA health care and benefits for Veterans exposed to burn pits, Agent Orange, and other toxic substances. This law helps us provide generations of Veterans—and their survivors—with the care and benefits they've earned and deserve. And starting March 5, 2024, we're expanding VA health care to millions of Veterans—years earlier than called for by the PACT Act.

The VA website will help answer your questions about what the PACT Act means for you or your loved ones. You can also call VA at 800-698-2411 (TTY: 711). And you can file a claim for PACT Act-related disability compensation or apply for VA health care now.

#### **Legislative Report** by Ray Collins

We now have one quarter of the year in the books. Guess what, we are gearing up to fight the same battles we have engaged in for far too long. I know all you MOAA people are well aware of the issues of which I speak.



I will begin with the injustice to end all injustices. The Major Richard Star Act finally passed last years' session of Congress but went unfunded in the National Defense Authorization Act. We currently have HR-1282 and S-344 with the support of 75 percent of Congress. Now all that remains is for US --- You and Me, to keep the pressure on Congress to ensure that the funding for these two Bills is included in the FY 2025 National Defense Authorization Act.

The travesty to end all travesty is the Department of Defense (DoD) withholding 5 percent of a service members Basic Allowance for Housing. We can't lay this burden on the door step of Congress; this burden was purely a swipe of the DoD. If DoD is really concerned about the plummeting morale, enlistment, and reenlistment rates, they can go looking for their next swipe somewhere other than the service members bank account. The house bill to correct this morale squelcher is HR-2537 and the Senate is S-1823. There are currently 59 cosponsors for the House bill and two for the Senate.

Beware the Congressional Budget Office. Although there are no legislative actions proposed for TRICARE for Life, the Congressional Budget Office posted a proposal that an annual enrollment fee or cost sharing would be an option to help lower the federal deficit. I seriously doubt a cut in this service-earned benefit would be as lucrative as would closing the borders.

My hope is that we will do our part in righting the ship on these costly issues by calling Senators Tuberville and Britt's attention to the thought of losing your vote - - - 202-224-4124 and 202-224-5744 respectively, and Congressman Moore at 202-255-2901.

#### Good News for Bad Times (Luke 3:1-6) from www.bible.org

In the early 18th century, England was infected with a plague of materialism. The gap between the rich and poor was widening, but moral degeneracy marked every level of society. The Prime Minister, Robert Walpole, led an openly immoral life and often made fun of virtue. Moral laxity pervaded the nation. Drunkenness, gambling, and cruel amusements were an obsession. Crime was rampant, and criminal law was unfair and barbarous, making criminals only more desperate. The Church of England had, for the most

part, ceased to be a vital force. Many ridiculed and railed at the Christian faith without reserve (these conditions summarized from A. Skevington Wood, The Inextinguishable Blaze [Eerdmans], pp. 9-16).

God broke into this dismal and seemingly hopeless situation by saving a young man, George Whitefield, who had been raised in his mother's inn and tavern. His friends, John and Charles Wesley, also were saved out of their legalistic religion to a living faith inthe Redeemer. Through these men, the good news of God's salvation spread to that decadent society and saved it from the brink of anarchy and revolution. In his biography of Whitefield, Arnold Dallimore observes (George Whitefield [Cornerstone Books], 1:25), We shall need to remember that it was among a people broken by gin that Whitefield and the Wesleys went about in the nobility of their ministries, and that there was triumphant meaning to Charles Wesley's lines on the deliverance effected by the Gospel:

Hear Him, ye deaf! His praise ye dumb, Your loosened tongues employ; Ye blind, behold your Savior come, And leap ye lame for joy! He breaks the power of cancelled sin, He sets the prisoner free! His blood can make the foulest clean, His blood availed for me! That same liberating, powerful message is what we need for our dismal, spiritually dark times. Let's believe it, live it, proclaim it,

and pray that God would break through in our day with His powerful Word of salvation!






